FINE ART CATEGORIES (primary media examples)

Painting	oil, acrylic
Water Media	watercolor, gouache, egg tempera
Dry Media	pastel, charcoal, pencil
Printmaking/Mixed	silk-screen, clay, monoprint, etching, collage
3D Sculpture	bronze, clay, stone, steel, assemblage
Photography	film, digital

Please read prospectus carefully and complete all presentation needs and labels before arrival to minimize delays and exclusions.

ELIGIBILITY

- Limit two artworks per artist.
- LGAA member artists only. Join when you enter.
- Adult (18 years or older).
- All work must be original in concept and executed within the last 3 years by the artist.

INELIGIBLE ARTWORKS

- Compositions from published or copyright materials.
- Work done under instructor.
- Work previously shown at Art Museum of Los Gatos.
- Wearable art or jewelry.
- Functional ceramic/crafts.
- Installations and video/films.

SIZE

- Unconnected 2D pieces may not be entered as one unit.
- 2D Maximum shall not exceed 50" in either direction (including frame).
- 2D Minimum image size 8" x 10" or 80 square inches (excluding frame).
- 3D art shall be stand-alone, not exceed 3' x 5' x 8' (120 cubic feet) or 75 pounds.

PRESENTATION

- Wall art adequately framed, wired, and ready for hanging.
- Wire in good condition and not attached to pressure clips.
- Mats neatly cut and clean in neutral or off-white preferred.
- Canvas edges clean or neatly painted and no visible staples.

- Plexiglas glazing preferred. Artist is responsible for any damage resulting from glass glazing.
- No protruding screw eyehooks.
- Flat D-rings preferred.
- No saw-tooth hanger or 'L' pins.

AWARDS

First, Second and Third Place awarded in categories with 15 or more entries. First and Second Place awarded in categories with 10 to 15 entries. First Place awarded categories with less than 10 entries. Categories with 5 or less entries may be combined with another category. Final determination regarding the appropriate category for each entry is made by juror.

USE LGAA ARTWORK LABELS

- Attach copy of LGAA Artwork Label from entry form in an upper corner on back of 2D art, or on the bottom of 3D art.
- Each LGAA label lists the artist's name, title, category, media, phone number, and retail value.
- No "Untitled" titling accepted.

SALES TAX and COMMISSION

All artwork must be for sale. The retail price printed in the program will be the retail price shown on the entry/label as calculated and written by the artist and should include the museum's 30% commission plus sales tax (8.25%) rounded up to the nearest \$1 or \$5 amount.

ENTRY FEES (non-refundable)

Incomplete or unsigned entry forms disqualifies entry. Checks payable to Los Gatos Art Association.

Early Entry fees apply when completed entry form and correct amount of fees are Received in Post Office Box by Friday, October 12.

Early Entry Fees: \$18 per item.

No changes or modifications to pre-registered Early Entries after October 12.

At-The-Door fees apply when entry form and correct amount of fees delivered with artwork on Art Intake Day, Sun., October 21.

At-The-Door Fees: \$25 per item

No changes or modifications to pre-registered Early Entries.

DELIVERY / ART INTAKE DAY

Art Intake Day. Sunday, October 21, Noon to 4:00 p.m. Hand deliver all artwork to Art Museum of Los Gatos. Museum does not accept shipments. PARKING is limited. Only drop-off area for heavy artworks and handicapped parking at museum. Other public parking areas are nearby.

ARTWORK RECEIPTS

On Art Intake Day, artists receive a receipt for each artwork entered. Receipt must be presented when picking up any artwork. If someone other than the artist picks up artwork, please present artist's written permission along with LGAA receipt.

PLAN AHEAD FOR PICK-UP

- Pick-up unaccepted entries on Tuesday, October 23, 6 to 8 PM. No exceptions.
- Exhibited artwork, even those

sold, may not be removed until close of show. No exceptions.
 • Each artwork not retrieved by stated pick-up times subject to a late fee of \$3 per day payable to Art Museum of Los Gatos.

Pick-up after stated times only when the Museum is open. It is closed between exhibits.
 • Art not picked up within 30 days becomes the property of Art Museum of Los Gatos

and may be used in future fund-raising events.
 • Failure to pay late fees, or checks returned for insufficient funds, or stopped payment may result in ineligibility for future shows ■
